## **Dear ACF Community,**

Over the course of our 2022-23 fiscal year, we sought to highlight composers as storytellers as we moved back to in-person activity while utilizing the digital connections strengthened during the pandemic. Deepening our commitment to racial equity, we were grateful to collaborate with a number of partners in realizing this shared goal, amplifying the impact of collaborating with living composers who reflect our world today. And we celebrated 40 years of our longtime record label, innova Recordings. Below are some highlights of our work over the year – which we hope will serve as examples and catalysts for a much longer journey of embracing living American composers as vital to our society.

# Immigration, Identity, and the Arts: Platforming Artists and Their Stories

In alignment with our commitment to fostering dialogue through art, we were excited to host a compelling series of events and conversations on the theme Immigration, Identity, and the Arts. Collaborating with the East Side Freedom Library, and inspired by Thi Bui's poignant graphic memoir, *The Best We Could Do*, we engaged with and platformed the lived experiences of individuals wrestling with this theme, including perspectives from the diverse immigrant populations in Minnesota. East Side Freedom Library – whose mission is to inspire solidarity, advocate for justice, and work toward equity for all – were wonderful partners in this collaborative effort. (We loved having Thi Bui join us, too!)

Through a combination of cultural events and conversations, both in-person and virtual, we created spaces that brought artists and community leaders together in dialogue, music, and literature. This initiative – supported by the NEA's Big Read, a program of the National Endowment for the Arts in partnership with Arts Midwest – engaged with the intersections of immigration and identity through the arts, cultivating a deeper understanding and connection within our community.

#### **Composing Inclusion: Collaborative Commissions for Multiple Generations**

In the spirit of serving as a catalyst for new opportunities to center living composers, we launched a partnership with The Juilliard School's Preparatory Division and the New York Philharmonic for a new program, Composing Inclusion. Powered by the Sphinx Venture Fund, this program is unique because composers who identify as Black and/or Latina/e/o develop new work with middle and high school age students over the course of a year, and design the music to be "flexible" for intergenerational ensembles. All works are being premiered over the course of two seasons by the Juilliard students and Philharmonic musicians in side-by-side concerts, and published by ACF for more performances elsewhere. The selected composers are: Jasmine Barnes, Nicolás Lell Benavides, Jordyn Davis, James Díaz, Thomas Flippin, Lauren McCall, Patricia Martínez, Andrés Soto, and Elijah J. Thomas. Trevor Weston was also commissioned – supported in part by a grant from the National Endowment for the Arts – and serves as advisor on the program. Our particular role has been to ensure that the composer's perspective is always at the "table," and that the composers themselves feel supported and involved throughout the program.

# **Our Racial Equity Framework: Defining the Path Forward**

As outlined in our commitment to racial equity statement and annual "report cards", we continue to work toward our goal to be a more equitable organization at all levels. This work includes ensuring meaningful participation from the artists we seek to support as well as our influence on the ecosystem that presents, performs, and receives their music. When space is created for more people to belong, it not only benefits artists and their networks, but also the world. Actions such as removing membership fees, inviting conversations, and being intentional about who is making funding decisions on our panels are all easy changes compared to the continued work to question assumptions, challenge the status quo, and try things that may feel uncomfortable. We are grateful for the engagement and trust from so many people who have been part of this journey with us. We will not stop.

On behalf of ACF's Board, staff, and artists, I express heartfelt thanks for being such an integral part of ACF.

# **About McKnight Composer Fellowship:**

The intent of the McKnight Artist and Culture Bearers Fellowship is to recognize and support artists and culture bearers who are beyond emerging and have sustained experience in their area of practice. Fellows demonstrate achievement, commitment, and high level proficiency in artistic and/or culture bearer practice that contributes to their field and impacts and benefits people in Minnesota.

# **About McKnight Visiting Composer Residency:**

The intent of the McKnight Visiting Composer Residency is to recognize and support artists and culture bearers who are beyond emerging and have sustained experience in their area of practice. Visiting Composers demonstrate achievement, commitment, and high level proficiency in artistic and/or culture bearer practice. This program invites artists to respond to, or reflect on, the unique qualities of people and communities in Minnesota.

#### About ACF | create:

American Composers Forum (ACF) champions composers and other creative music makers, and boosts their careers with professional opportunities. ACF | create is an evolution of the Jerome Fund for New Music (JFund), which started in 1979. Through this program, ACF has made hundreds of awards and has helped launch many careers. ACF | create supports the creation, presentation, and subsequent life of a new work. Five grants are available: up to \$8,000 for the composer or primary artist's time to create the work, and up to \$3,000 to help with production and promotion support. This program is for early career artists that reside in Minnesota or the five boroughs of New York City.

# About ACF | connect:

Launched in 2017, ACF | connect provides opportunities for composers to build relationships with leading American ensembles to create new work, reach new audiences, and engage with new communities. Past partnerships include the Pittsburgh New Music Ensemble (PNME), Roomful of Teeth, and The Great Black Music Ensemble: An Ensemble of the Association for the Advancement of Creative Musicians™ (AACM). Through this program, composers are offered competitive commission fees, and have significant time to both work with performers and participate in learning/networking opportunities with industry professionals. Ensembles are able to connect to a broader composer community and invite applicants from a national call. Consistent with the mission of American Composers Forum, the program supports meaningful, long-lasting connections between composers, performers, audiences, and the local community where the ensemble is based. The program intentionally supports a diversity of voices and music to advance creative musical expression as a core value of a global society. ACF | connect ensures a vibrant future for composers and their work by supporting their vision and creativity, and by pairing them with performers and audiences in traditional and innovative spaces and media.

#### **About Composing Inclusion:**

Composing Inclusion brings together multiple generations, musical levels, perspectives, and community members in the creation and performance of new music. Powered by the Sphinx Venture Fund, American Composers Forum (ACF), in partnership with The Juilliard School's Preparatory Division and the New York Philharmonic, co-commissioned nine music creators who identify as Black and/or Latina/e/o to create "flexible," adaptive scores for players of varied musical ability. The nine commissioned works (five works for orchestra, four for chamber ensembles) are developed in collaboration with Juilliard students and Philharmonic artists over the course of several months with premieres in New York City by Juilliard Preparatory Division students performing side-by-side with members of the New York Philharmonic. ACF is publishing the works and distributing them through Hal Leonard to engage more intergenerational ensembles with the music.





# PaviElle French: Artist Equity Summit 2022 Liberation! Lifting Up our Youth

## **About the Residency:**

Liberation! Lifting up our Youth, was a multi-part residency led by artist and St. Paul native PaviElle French, in collaboration with six St. Paul-based arts organizations. Developed from a desire to empower the young people of the community, French pursued activities over nine months that included workshops, commissions, and performances. The focus of the residency was on "lifting up our youth" to connect, express themselves, and share their thoughts through music. The six participating organizations included The Saint Paul Chamber Orchestra, Walker | West Academy, Schubert Club, Purple Playground, TruArtSpeaks, and American Composers Forum.

#### About the Summit:

Annually, ACF organizes an Artist Equity Summit, a focal point for music creators exploring themes of equity in and beyond their fields. The 2022 theme, "Lifting Up our Youth," showcased young artists unveiling their methods for collaboration in creating music, sparking conversations on achieving racial equity across generations. This summit marked the culmination of artist PaviElle French's residency Liberation! Lifting Up our Youth, which arose from our collective commitment to empowering young individuals. Performances by Purple Playground and TruArtSpeaks students showcased original works developed in workshops with PaviElle and the student collaborators of each organization respectively. Additionally, we highlighted our new intergenerational commissioning partnership with The Juilliard School's Pre-College and the New York Philharmonic, known as "Composing Inclusion."

# **About the Program:**

American Composers Forum believes that music is a medium that can help us connect as humans, tell stories, and share experiences. East Side Freedom Library has long hosted study groups, partnerships, and community events that lift up the stories of its neighborhood in the name of justice. Together, we hosted several cultural events and conversations that examined the theme of "Immigration, Identity, and the Arts," aiming to amplify the voices, stories, and music of immigrant artists and community members grappling with this theme. Included in our events was a discussion of, and inspiration from, Thi Bui's graphic memoir, *The Best We Could Do*. Supported by the NEA's Big Read project, this book aligned greatly with our theme and resonated with numerous members of our community.


