Fellows demonstrate achievement, commitment, and high-level proficiency in artistic and/or culture bearer practice that contributes to their field and impacts and benefits people in Minnesota.

The addition of culture bearer acknowledges that the McKnight programs support creative leaders in Minnesota from cultures that don't use the word "artist" (such as Native American and Hmong), as well as those who center the transmission and preservation of cultural lifeways.



#### **McKnight Artist Residencies Consortium**

The McKnight Artist Residencies consortium is a partnership between Artist Communities Alliance (ACA) and the McKnight Foundation. The consortium is designed to build equitable capacity in the artist communities field and connect McKnight Artist Fellows with national and international residency opportunities.

This multi-year regranting partnership provides direct support to artists to attend residencies and to residency programs to host artists.

This consortium aims to support the development of residency environments where any artist or staff member can thrive. Participating residencies will receive resources and guidance around assessing and building their equitable capacity — enabling programs to develop fair and just policies and practices, and begin to dismantle white body supremacy. The residency program partners will participate in a peer working group and receive dedicated training on ACA's Healthy Residency Framework. In addition to this learning process, participating residencies will host McKnight Artist Fellows for 1-2 week stays in 2023 and 2024.

#### About the McKnight Foundation's McKnight Artist Fellows:

Founded on the belief that Minnesota thrives when its artists thrive, the McKnight Foundation's arts program is one of the oldest and largest of its kind in the country. Support for individual working Minnesota artists has been a cornerstone of the program since it began in 1982. The McKnight Artist Fellowships Program provides annual, unrestricted cash awards to outstanding mid-career Minnesota artists in 14 different creative disciplines. Program partner organizations administer the fellowships and structure them to respond to the unique challenges of different disciplines. Currently, the foundation contributes about \$2.8 million per year to its statewide fellowships. For more information, visit mcknight.org/artistfellowships.

# Eligibility & Application Process

### Eligibility Requirements

- Residency in Minnesota\*
- ✓ US Social Security Number or US Tax ID (such as an ITIN)
- Beyond early practice with sustained experience\*
- Achievement, commitment, and proficiency in music creation
- ✓ Not applying for another McKnight Artist Fellowship this program year\*
- ✓ Not received a McKnight Artist Fellowship in the last five award years\*
- ✔ Growth and ongoing artistry if a previous McKnight Fellow
- ✓ Not affiliated with the McKnight Foundation or fellowship partners\*
- ✓ Not enrolled full-time in an academic program\*

Hooray, I'm eligible! Time to apply!





### Key Evaluation Criteria

#### A. Artistic craft:

- 1. Strong sense of the creator's voice
- 2. Technical proficiency necessary to achieve the desired results
- 3. Quality of work samples\*
- B. The applicant has clearly reached beyond early practice, as evidenced by the following:
  - 1. Significant body of work
  - 2. Creative achievement
  - 3. Sustained contribution to their artistic field and Minnesota's arts ecosystem

### **Selection Process:**

#### Prescreening by ACF staff

- Eligibility and completeness
- Panel support and adherence to discussion guidelines
- ACF staff members do not contribute to decision-making or selection of awardees

#### Panel Review

- Four music creators & advocates
- Two phases
  - 1. Independent Review
  - 2. Group Review with two rounds

#### Panel Review Process:

Phase 1: Independent Review:

Each panelist independently assesses applications in a randomized order and scores them based on the six key evaluation criteria

- Panelists will only listen to up to 5 minutes of Work Sample 1 in this phase.
- About 50% of the applications will be passed on to the next phase based on the panelists' combined scores and review of the list.

### Panel Review Process:

Phase 2 – Panel Group Review:

Panelists listen to forwarded applicants' music together in two rounds, having conversations in which they will make comparative judgments about each applicant.

- Round 1: Panelists adjust scores on the key evaluation criteria as needed and select between ten and fifteen applications to proceed to the next round.
  - Panelists may revisit Work Sample 1, this time collectively.
    - You can indicate alternative cue times for this review stage
  - Panelists listen to Work Sample 2 and 3 (if applicable)
- Round 2: Panelists will provide an overall score and select the four awardees, alternates, and honorable mentions.
  - Panelists will revisit all work samples as needed.

### In a successful McKnight Fellowship application, I look for...

...artistic clarity, authenticity, and a strong sense of purpose and empathy.

...a sense of honesty

...uniqueness/singularity

...a sense of unity in the application where points connect--can I get a good feel

for who this person is, where they are coming from, and how their life connects to

their work?

### In a successful McKnight Fellowship application, I look for...

...a sense of urgency in why this artist creates music

...a history of consistent creative output

...spark, zip, and an unmistakable sense of drive.

...solid craft and the personality and imagination to make things happen

...the ability to collaborate deeply

...spark, craft, and follow-through

...a mix of vision, skill, and energy that makes an artist impossible to ignore.

### Online application via SlideRoom

(SlideRoom is a web-based application platform)

#### Components of the application:

- 1. Applicant's personal information
- 2. Demographic form\*
- 3. Work samples and supporting materials\*
- 4. Artist's statement\*
- 5. Insights into your artistic experiences\*
- 6. A complete works list\*
- 7. Questions regarding social media and how you learned about the opportunity
- 8. Acknowledgement of McKnight Artist Fellowship Community Values
- 9. Acknowledgement of Terms and Conditions

### Application Deadline:

Wednesday, Dec. 17, 2025 at 11:59pm PST



If you start your application before the deadline, you will have a 24-hour grace period to submit your application. If you do use this grace period, you must submit your application before December 18, 2025 at 11:59pm PST. After this, we will not accept any applications, without exception.

# Work Samples & Supporting Materials

### **WORK SAMPLES**

#### General Guidelines

- Provide 2 or 3 audio and/or video samples of your original music.\*
- At least one of your work samples should be of a work you created in the past five years.
- If you have previously received a McKnight Fellowship, concentrate your work samples on the period of time since your last award.

### WORK SAMPLES

#### Work Sample 1

Makes the most critical impression on the panelists & should represent your most distinctive and compelling musical example

Work Sample 2 (& optional 3)
Complements the previous work samples

- Connect directly to your Artistic Statement
- Demonstrate the significance of each sample with a written description\*
- Supporting materials (scores\*, lyrics, etc)

 Choose a sample that, in combination with other samples, demonstrates the depth and/or breadth of your artistic practice

#### **WORK SAMPLES**

#### The technical stuff

- Always include start and end times
- If notated scores or other instructive materials are part of your creative process, provide PDFs corresponding to your samples.
- Applicants whose work samples involve lyrics are encouraged to provide lyric sheets.
- We are open to receiving many types of sonic representation for the review process, including video, spectrogram, waveform, graphics, etc.
- Please note that panelists cannot access music notation or specialized software directly.

### **Supporting Documentation**

- Your Artistic Statement may take any of several directions at your discretion. Craft a statement that provides the most compelling context for your work samples, such as information about your background, the development of your work, your interests as an artist or your aesthetic position, your future artistic direction, your career status, self-assessment, etc.
- Enhance your artistic statement by sharing information about and insights into your artistic experiences.\*
- Give a broader scope of your work with a complete works list.\*

### Reminders and recommendations:

- Save as you go, return as needed.
- Test your links, leave them up until Feb 9.
- Work Samples
  - 5 minute maximums
  - Start/end times
- Artist's statement, insights, and work descriptions matter.
